Call for a Photographic Exhibition "An Album on Rights"

The Inter-American Children's Institute (IIN) is the specialized agency of the OAS responsible of promotion of studies related to children, adolescents and the family in the Americas and to generate technical instruments that improve the performance of States in the promotion and protection of the Rights of children and adolescents through their public policies.

The IIN was founded on June 9 1927. This year on the occasion of celebrating its 90th anniversary, and with the purpose of promoting and encouraging the participation of children and adolescents in the region, we convene you to be part of the photographic exhibition: The Album on Rights.

Objectives. Celebrate the Institute's 90 years of existence by promoting an expressive - creative space, collecting children's and adolescents perspectives on the promotion and protection of their rights through photography

Theme. The photographs must refer to the vision that children and adolescents have of the effective exercise of their rights, and their relationship with the adult world.

Participants. The photographer must be citizen and or resident between the ages of 6 and 17 of the member states of the Organization of American States (OAS)

Categories: Between 6 and 12 years and from 13 to 17 years.





BASES AND CONDITIONS

- 1. Participation in this Call is totally free
- 2. The works must be unpublished (not published by print or electronic means), and not awarded in other competitions.
- 3. The works must be exclusive of the author (children and adolescents must be the photographers). Participants will be responsible for ensuring that photographs are their exclusive property.
- 4. Twenty photographs will be selected that will form a traveling exhibition that will be visited by OAS Member States.
- 5. The authors of the selected photographs will be informed via email or telephone, once the Selection Committee convened by the IIN issues the results.
- 6. Participants transfer to the Inter-American Children's Institute (IIN-OAS) all rights to use, reproduce and disseminate the photographs and explanatory texts submitted to the Call. The use, reproduction and dissemination by the IIN will always be carried out with a non-profit purpose and mentioning the author. The photographs received may also be used to illustrate various activities of the IIN.
- 7. The final results will be published on the IIN is website and the selected works will be in the IIN's Digital Project "Rights Album".
- 8. The sole presentation to the Call implies the of its bases.
- 9. The selected participants will receive a certificate of recognition giving an account of this situation.





TECHNICAL REQUIREMENTS

- 1. The modality of participation is digital photography.
- 2. Photographs can be colored, black and white or sepia.
- 3. The works must be original without retouch of postproduction (Example: Photoshop).
- 4. They must be presented in JPG format, at 300 dpi (dots per inch) of resolution, no larger than 20 x 30 cm and weighing not more than 5 MB.
- 5. A maximum of 2 photographs per participant can be sent.
- 6. The papers will be sent through the link: http://iinadmin.com/public/photographic-exhibition/. Each participant will attach their photographs and enter the following data:
 - Title of the image.
 - Explanatory text on the subject of photography and what it represents, not to exceed 100 words, in one of the four official languages of the OAS (Spanish, English, French, Portuguese).
 - Data of the author: Name, surname, age, country, address (complete), telephone and email.
 - Data of mother, father, representative or person responsible for the author: First name, last name. This information will only be used for contact and / or information purposes related to the exhibition.
- 7. Works that do not meet these requirements do not participate in the selection.

Reception of works: From February 1 to June 9, 2017.

The IIN will establish, in a timely manner and in agreement with the national authorities of each country, a timetable for the presentation of a traveling exhibition.

In the countries in which the selected children or adolescents live, the author will act as presenter of the sample and member of the table presenting the exhibition.
