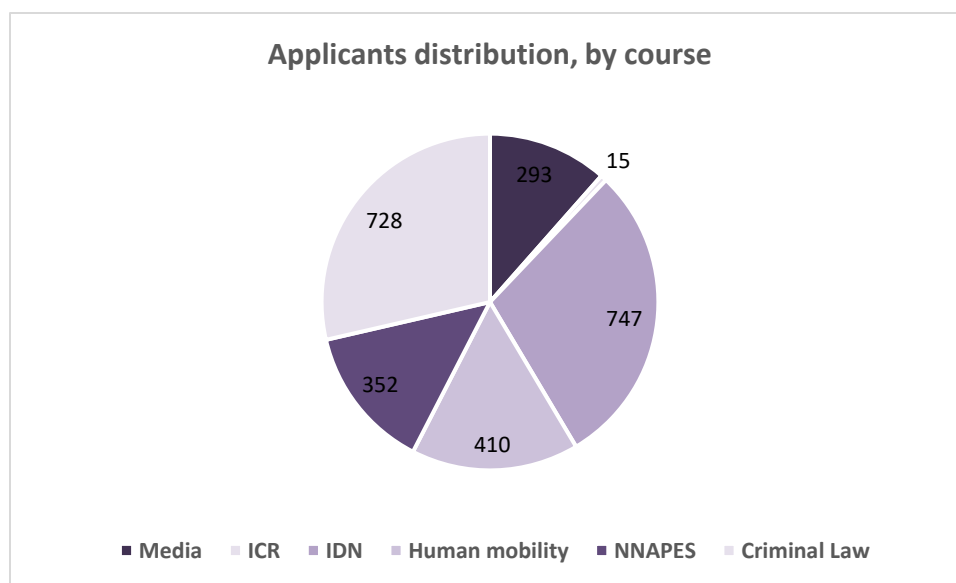
VIRTUAL COURSES – REGULAR OFFER – FIRST SEMESTER

- Youth in conflict with criminal law

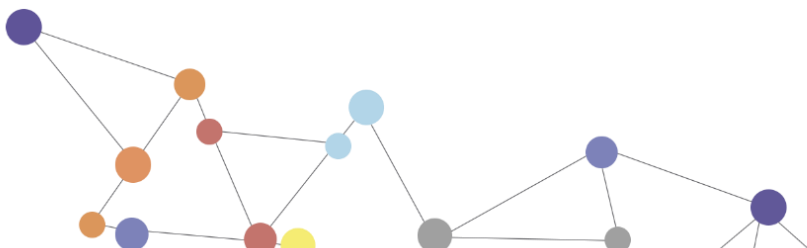
Through the open call, **2,545 applications** were received, according to the following detail:

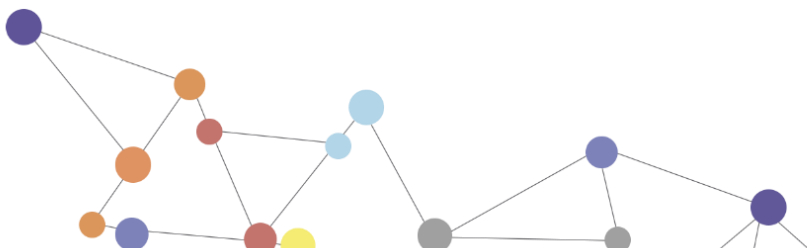

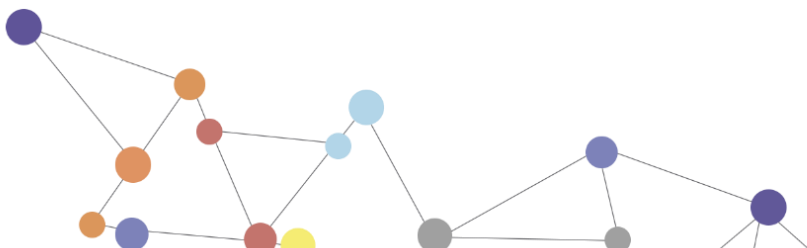
