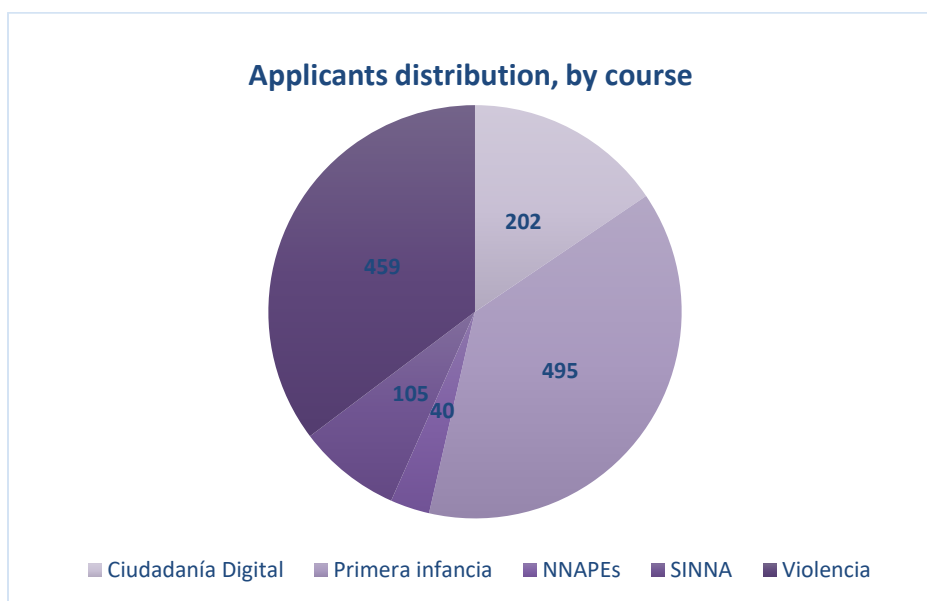
VIRTUAL COURSES – REGULAR OFFER – SECOND SEMESTER

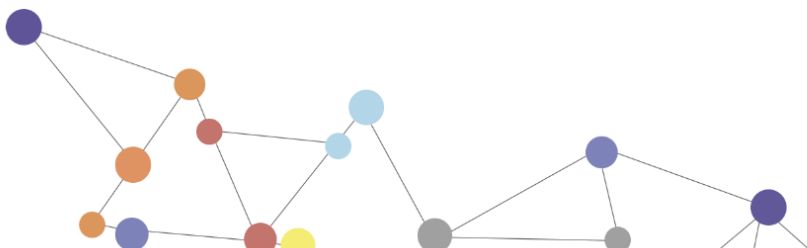
